# Maryland Women in Elected Office

## A 2025 Status Report

**The 2024 elections sent three women to Congress from Maryland after an eight-year drought with no women in our ten member federal delegation.** Today, Maryland is ranked eighth in the country for the percentage of women in our state legislature, down from first in 2006. From County Commissions to the Maryland General Assembly, women consistently make up less than half of all membership, and less than a third of leadership roles.

### WOMEN IN STATE EXECUTIVE OFFICE

- Maryland has two women among four elected statewide executive branch officers.
- Maryland currently has its first female Comptroller and second female and first woman of color Lieutenant Governor.
- Maryland is one of 20 states that has never had a woman as Attorney General.
- **Maryland is one of 18 states that has never had a woman as Governor.**

### MARYLAND WOMEN IN CONGRESS

In the 2024 election, Maryland gained three women in its congressional delegation. This is an increase from no women for the past eight years. Angela Alsobrooks was elected to the U.S.

Senate, April McClain Delaney was elected to represent District 6 and Sarah Elfreth was elected to represent District 3 in the House.



# MARYLAND CONGRESSIONAL REPRESENTATION



# MARYLAND WOMEN IN THE STATE LEGISLATURE

The Maryland House has 63 women out of 141 Delegates. The Maryland Senate has 13 women out of 47 Senators. This makes Maryland eighth in the nation for women in the legislature, a decrease from 2005-2006 when it was first in the nation. This is a decrease from 2005-2006 when Maryland was first in the nation. The percentage of women in the Maryland Senate is lower today than it was in 2003, and it's still trending downwards.

## REPRESENTATION IN THE MARYLAND SENATE

- Women make up only 30% of the Senate.
- Women comprise 35% of the Democratic Caucus.
- There is only one Republican woman among 14 Republicans in the Senate.
- There is only one member of the LGBTQ+ Caucus in the Senate. She is a Black woman.
- There is one woman Senator of Middle Eastern/North African (MENA) heritage.
- Latinos have no representation, male or female, in the Maryland Senate, despite making up 12.6% of the state's population. Proportional representation would be six Senators, three women and three men.
- There are no Asian American women in the Maryland Senate, although Asian American and Pacific Islander (AAPI) women make up 4.3% of the state's population. Proportional representation would require two more AAPI Senators, one or both of them a woman.
- 34% of Maryland Senators are Black, putting Maryland's representation in line with its population. However, only three of the Black Senators are women, making Black women significantly underrepresented in the Maryland Senate. Proportional representation would be seven or eight Black women in the Maryland Senate.

## WOMEN IN SENATE LEADERSHIP

- Four of the 12 leadership positions in the Senate are held by women\*
- One of four policy committees in the Senate is chaired by a woman
- One of six Senate Vice Chairs is a woman: Education Energy and Environment Committee Vice Chair Cheryl Kagan

## REPRESENTATION IN THE MARYLAND HOUSE

- Women make up 45% of the House, and a majority of the House Democratic Caucus.
- Republican women are still underrepresented.
- The majority of women legislators in the House are women of color.
- The Black Caucus in the House is 61% women.
- Among AAPI, Latino and White Delegates, men still outnumber women.
- 3 of 7 LGBTQ Caucus members in the Maryland House are women.

## WOMEN IN HOUSE LEADERSHIP

- Four of the 13 leadership positions in the House are held by women.
- Two of the six policy committees in the House are chaired by women.
- Speaker Adrienne A. Jones is the first woman and first person of color to serve as Speaker of the House.
- Of the Vice Chairs and Subcommittee Chairs, more than half (22) are held by women.

## WOMEN IN MARYLAND'S COUNTY GOVERNMENT LEADERSHIP

- Four of Maryland's nine County Executive positions are currently held by women.
- Baltimore County Executive, Kathy Klausmeier, was appointed in January 2025 by an all-male County Council to complete the term of former Executive, John Olszewski, who is now representing District 2 in Congress.
- Prince George's County Executive, Aisha N. Braveboy, was elected in a June 2025 special election to complete the term of former Executive, Angela Alsobrooks, who now serves in the U.S. Senate.
- **Montgomery County, Maryland's largest jurisdiction, is the only jurisdiction with an Executive to have never elected or appointed a woman to this role.**



## WOMEN ON COUNTY COUNCILS OR COMMISSIONS

- All Maryland jurisdictions have a city/county council or a board of county commissioners.
- 11 counties in Maryland have no women on their board of commissioners. These counties are Allegany, Baltimore, Caroline, Carroll, Dorchester, Garrett, Kent, Queen Anne's, Somerset, St. Mary's, and Washington County.



## WOMEN'S ISSUES ON THE BALLOT

### RESULTS OF 2024 QUESTION 1: THE REPRODUCTIVE FREEDOM CONSTITUTIONAL AMENDMENT



- **76% of Marylanders voted YES when asked whether the right to abortion and contraception should be included in the Constitution.**
- Every region of the state voted in support.
- Garrett County is the only jurisdiction without majority support. However, the referendum was extremely close, with proponents falling only 1,569 votes short of a majority.
- This is an 83% increase in pro-choice support in Garrett County since 1992.
